Promotional Period for Introductory APR:

The Introductory APR for purchases will apply to transactions posted to your account during the first six months following issuance of your card.

The Introductory APR for balance transfers will apply to transactions posted to your account until 6/30/2021. Any existing balances on Nizari Progressive Federal Credit Union loan or credit card accounts are not eligible for the Introductory APR for balance transfers.

Loss of Introductory APR:

We may end your Introductory APR for purchases and balance transfers and apply the prevailing non-introductory APR if you are 60 days late in making a payment.

Effective Date:

The information about the costs of the card described in this application is accurate as of: December 31st, 2020. This information may have changed after that date. To find out what may have changed, contact the Credit Union.

For California Borrowers, the Standard Mastercard and Platinum Mastercard are secured credit cards.
